# SUBMISSION TO THE COMMISSION OF ENQUIRY

## Recommendation

That Council engage Hunt & Hunt Lawyers to assist with the preparation of a submission to the Commission of Inquiry on behalf of the Councillors.

## 1. Executive Summary

A Commission of Inquiry is underway in relation to the affairs of the Council. An opportunity is available for a joint submission to be prepared on behalf of the Councillors in response to the enquiry.

## 2. Conflict of interest declaration

There are no conflict of interest considerations as part of this report.

## 3. Background & Context

On 28 October 2022, a Commission of Inquiry into Moira Shire Council was appointed under section 200 of the Local Government Act 2020.

The Commission was established to conduct an inquiry into the affairs of the Council.

Two commissioners with relevant expertise have been appointed:

- Ms Frances O'Brien KC Commissioner and Chair of the Commission of Inquiry. Ms O'Brien was the Chair of Ararat Commission of Inquiry and a Commissioner for Geelong, and
- **Mr John Tanner AM** as Commissioner on the Commission of Inquiry. Mr Tanner was a former member of the Ministerial Panel Local Government Rating System Review, former Ararat Commissioner and former Brimbank administrator.

The Municipal Monitor's appointment concluded when the Commission of Inquiry commenced.

#### 4. Issues

The Terms of Reference for the Commission of Enquiry include:

- To conduct an inquiry into matters relating to the affairs of the Moira Shire Council (the Council), including through an examination of:
  - The confidential advice provided to the Minister for Local Government by the municipal monitor dated 7 October 2022 and the confidential letter provided by the Australian Services Union dated 5 October 2022;
  - Any matters affecting the Councillors' performance of their roles;
  - Any matters affecting the Council administration's performance, including human resource practices;
  - The efficiency and effectiveness of the Council's governance arrangements in delivering services to its constituents, including financial management and community engagement practices; and

## SUBMISSION TO THE COMMISSION OF ENQUIRY (cont'd)

- Any other matters identified by the Commission of Inquiry that have an impact on the Council's ability to function.
- To report to the Minister for Local Government in writing on the matters outlined above by 28 February 2023.
- If the Commission of Inquiry determines to make an order for the payment of costs of the Commission of Inquiry under section 214 of the Act, to provide the reasons for any determination that the Council should not be responsible for all of the costs.

## 5. Strategic Alignment

This report aligns with the Council Plan Strategy of Transparent and Accountable Governance.

## 6. Internal & External Engagement

Internal consultation occurred with all Councillors in relation to this opportunity. No external consultation was required.

## 7. Budget / Financial Considerations
