ELECTION OF THE MAYOR

ITEM NO: 7.1

1. Executive Summary

The Chief Executive Officer will call for nominations for the election of Mayor of the Moira Shire Council in accordance with the *Local Government Act 2020* (the Act) and Moira Shire Council's Governance Rules.

The election of the Mayor is usually held at a meeting open to the public, however, due to Covid-19 this meeting is closed to the public. The Covid-19 Omnibus (Emergency Measures) Act 2020 allows for Council meetings to be live streamed. The election of the Mayor can be viewed via Moira Shire's social media page and website.

2. Background and Options

Section 25 of the Act outlines the requirements and Council must elect the Mayor within one month of a general election.

Before a Mayor is elected, the Council can determine by resolution whether the Mayor is to be elected for a 1 year or a 2 year term. Moira Councils in the past have adopted a one year term. Any Councillor is eligible for election or re-election to the office of Mayor.

The process for the election of the Mayor is prescribed in section 5.3 of Council's Governance Rules.

Method of Voting

The election of the Mayor must be carried out by a show of hands and made in accordance with rule 8.2(1), an electronic method that enables those observing (in attendance and those watching a livestream broadcast) to see who a Councillor has voted for at the time the vote is taken.

Determining the Election of Mayor

- (1) The Chief Executive Officer will preside during the election of the Mayor.
- (2) The Chief Executive Officer must invite nominations for the office of Mayor and confirm acceptance of the nomination with the nominee. Councillors cannot self-nominate and a nomination does not require a Councillor to second the nomination.
- (3) Where in an election for the Mayor:
 - (a) only one candidate has been nominated, that candidate must be declared elected;
 - (b) two candidates have been nominated, a vote must be taken and the candidate who receives a majority must be declared elected.
 - (c) two candidates have been nominated and no candidate receives a majority, the vote will be determined by lot.
 - (d) more than two candidates have been nominated and no candidate receives a majority vote from the Councillors present:
 - I. the candidate with the fewest number of votes cast must be eliminated;
 - II. the names of the remaining candidates must be put to the vote again; and
 - III. the procedure in 0 and 0 above must be continued until there remain only two candidates, at which point the candidate to be declared elected is to be determined by the procedures outlined in sub-clause 0 of this Clause.

ELECTION OF THE MAYOR (cont'd)

- IV. in the event of two or more candidates having an equality of votes the elected candidate shall be determined by lot.
- (e) The provisions of sub- rules 0 and 0 apply to the election of the *Deputy Mayor* with all necessary modifications and adaptations.

ELECTION OF DEPUTY MAYOR

ITEM NO: 7.3

1. Executive Summary

The *Local Government Act 2020* (the Act) allows Council to elect a Deputy Mayor. The election of the Deputy Mayor will be conducted in accordance with the Act and Moira Shire Council's Governance Rules.

The election of the Deputy Mayor is usually held at a meeting open to the public, however, due to Covid-19 this meeting is closed to the public. The Covid-19 Omnibus (Emergency Measures) Act 2020 allows for Council meetings to be live streamed. The election of the Deputy Mayor can be viewed via Moira Shire's social media page and website.

It is recommended that Council appoint a Deputy Mayor for the period ending on the date of the next Mayoral election.

2. Background and Options

The duties of the position of Deputy Mayor include taking on the role of acting Mayor in accordance with section 25 of the Act.

Method of Voting

The election of the Mayor must be carried out by a show of hands and made in accordance with rule 8.2(1), an electronic method that enables those observing (in attendance and those watching a livestream broadcast) to see who a Councillor has voted for at the time the vote is taken.

Determining the Election of Deputy Mayor

- (1) The Mayor will preside during the election of the Deputy Mayor.
- (2) The Mayor must invite nominations for the office of Deputy Mayor and confirm acceptance of the nomination with the nominee. Councillors cannot self-nominate and a nomination does not require a Councillor to second the nomination.
- (3) Where in an election for the Deputy Mayor:
 - (a) only one candidate has been nominated, that candidate must be declared elected;
 - (b) two candidates have been nominated, a vote must be taken and the candidate who receives a majority must be declared elected.
 - (c) two candidates have been nominated and no candidate receives a majority, the vote will be determined by lot.
 - (d) more than two candidates have been nominated and no candidate receives a majority vote from the Councillors present:
 - I. the candidate with the fewest number of votes cast must be eliminated;
 - II. the names of the remaining candidates must be put to the vote again; and
 - III. the procedure in 0 and 0 above must be continued until there remain only two candidates, at which point the candidate to be declared elected is to be determined by the procedures outlined in sub-clause 0 of this Clause.
 - IV. in the event of two or more candidates having an equality of votes the elected candidate shall be determined by lot.
