Section 223 of the Local Government Act 1989

This form can be used to make a submission to the proposal to retain the annual allowances for the Mayor & Councillors at the maximum limit set for a Category 2 Council. A submission simply means you provide Council with a written document that outlines your feedback. You can attach further documentation and you also have the opportunity to speak/present in support of your submission.

Your submission must:

- ✓ be received by Council by 5pm Wednesday 28 April 2021.
- ✓ be submitted in one of the following ways:

 - in person to our Cobram or Yarrawonga Service Centres, or

- ✓ provide details that ensure we can contact you.
- ✓ indicate whether you, or a nominee would like to speak about your submission at our Committee of Council Meeting at **6.30pm Wednesday 12 May 2021**.

The meeting will be live streamed and you will be able to appear by virtual means. If you indicate you wish to speak to your submission, we will contact you before the 12 May to confirm your presentation time.

What happens to your submission?

All submissions received by Council by 5pm on Wednesday 28 April 2021 will be considered.

A recommendation will then be prepared for Council's consideration at the Scheduled Council Meeting on Wednesday 23 June 2021.

Council will provide a written response to all submissions – these will be provided after Council makes a decision.

All submissions (including submitter's name and address) will be available at the Meeting and on public display for the following 12 months.
