Background



- 2012 event
 - 200 300mm Feb/March
- Numurkah Floodplain Man't Study & Report Nov 2017
 - Advisory Committee & Community Consultation
 - Extensive catchment analysis & hydraulic modelling
 - Good calibration 1993 & 2012 events
 - 2012 event very similar to the modelled 1% design event
 - Up to 15 mitigation options modelled
 - Final report included 3 Options Packages A,B & C
 - Mitigation package A Recommended
 - Community consultation early 2018
 - Council Adopted report in 23 May 2018
 - Noted Mitigation Option A as preferred
 - Established Implementation Advisory Committee.


Mitigation Package A



- Northern Levee
- Southern Levee X 2
- In-stream creek works channel enlargement desilting
- Removal of soil mounds Go-Cart track
- Raising/Lowering of Nathalia-Katamatite Rd
- Removal of Irrigation Delver
- Non-return valves on drainage inlets
- General
 - Levee = Approx. 10km long. (Northern = 4.5km)
 - Freeboard = 450mm earthen and 300mm masonry.
 - Cost Est \$16.9m


Stage 1 – Northern Levee



- Northern Levee 4.5km
- Funding \$3.176m (\$2.382m grant + \$794k Moira)
- Agreed Design parameters (Committee)
 - Alignment amendments
 - Needham St, Council depot, Saxon St/Lakeside & Brooke Crt
 - Hydraulic Modelling Completed Assumptions
 - No creek works
 - No Road adjustments
 - Irrigation Delver removed
 - Tunnock St development


Stage 1 – Hydraulic Modelling





Stage 1 – Tunnock Rd Development






Stage 2 – Hydraulic Modelling – (Current Assumptions)

Stage 1 – Current Activity - implementation



- Other Design/Approval works
 - Brennion St Pump station review & design TBC
 - Cultural Heritage Assessment Engaged
 - Flora and Fauna Study Engaged
 - Planning Consultancy TBC
- Detailed design
 - Land tenure v's alignment avoiding acquisition & sensitive areas
 - Interaction at key points GV Hwy, Rail Line, Pump station, Rose Garden, Band Hall & GVWater tower, Road Crossings.





















Stage 1 – Northern Levee



- Timeframes
 - Detailed Design July 2023
 - Approvals September 2023
 - Civil Contract procurement Sept/Oct 2023
 - Works commence late 2023/early 2024
 - Works complete 2024
- Considerations
 - Cultural Heritage outcomes.
 - Planning Objections.
 - Final Cost Estimates
