Asset Management Plan Appendix 1.11 Recreation Reserves 2009

1. Introduction

This plan covers the management of all recreation reserves on Council land and crown land for which Council is the committee of management. Council has established local committees under Section 86 of the Local Government Act 1989 to manage the recreation reserves and the assets contained on them.

2. Levels of Service

Moira Shire Council in conjunction with the Section 86 committee will maintain the recreation reserve assets. The areas of responsibility have been determined and are recorded in the Section 86 Committees of Management, Operations and Risk Management Manual (February 08)

3. Future Demand

As current and future development is generally located adjoining or near already established areas and because of greater mobility of the public, it is expected that there will not be a need to increase the number of recreation reserves in the Shire.

4. Asset Portfolio

Council's recreation reserves are listed at the end of this AMP. They are also recorded in Council's corporate asset data base – Conquest.

5. Risk Management

Regular inspections are carried out by members of the Section 86 committee. As a result of these inspections, a further inspection may be required by Council's building maintenance team.

6. Acquisition Plan

Although it is expected that no additional Council recreation reserves will be required, there will be community demand to improve and increase the existing assets at the recreation reserves. Council will consider business cases for these projects as part of the 10 year Capital Expenditure Program and the Annual Budget process.

7. Operations & Maintenance

8. Renewals / Replacement

Renewals / replacements of public halls are funded on an annual basis, as part of the Building Renewal Program.

9. Disposal

Should a recreation reserve asset be no longer required for its intended purpose, Council will determine the future of the asset.

11. Monitoring & Improvement Program
