Cat Trap Hire

Information & Conditions of Use

Cat Traps

Moirá Shire Council has a limited number of cat traps available for loan to residents to catch cats on their property. A refundable deposit of \$100 is required for the loan of a cat trap.

To arrange delivery or collection of a cat trap, please contact Moirá Shire Council.

Traps can be collected from Moirá Shire Council's offices in Cobram or delivered, subject to availability.

Traps will be loaned for seven (7) days, upon application.

Trapped cats will only be collected during office hours, Monday to Friday, 9am to 4.30pm.

All cats caught are to be humanely treated. Arrangements are to be made with Moirá Shire Council for collection as soon as possible.

Council may decide that a property is not suitable for a cat trap.

Setting a trap

Do

- Place the trap in an area frequented by cats
- Place the cat once trapped out of harsh weather conditions (direct sunlight/rain).
- Cover the trap with a hessian bag or similar once the cat is caught (this reduces stress to the cat).
- Contact Moirá Shire Council as soon as possible after the cat is caught.
- Use fresh meat, cat food or fish as bait

Don't

- Set the trap between 3pm Friday and 8am Sunday
- Remove collar/tags from any cat once caught
- Attempt to remove the cat from the cage, as injury may occur to the handler and/or cat.
- Injure or harm the cat in any way. This is an offence against the *Prevention of Cruelty To Animals Act 1986*
