# TRANSFER OF LAND - REALIGNMENT OF BOUNDARY 64 PUNT RD COBRAM, WOOLWORTHS SITE

Council has previously considered the issue of realigning the boundary of the Punt Road car park in Cobram at its meetings of 25 June 2012 and 20 August 2012.

The shape of the allotments that Council owns, predominantly the car park, and the Woolworths site, are very unusual. The area surrounding the rear of the Woolworths building and the loading area is constrained by land that Council owns.

The proposal was to exchange land between the owners of the properties, Council and the developer of the Woolworths site, to bring the boundaries of the land to more closely reflect the use, and provide additional car parking space for shoppers within Cobram.

At its meeting of 20 August Council resolved;

#### That:

- 1. Council adopt and approve the proposal to exchange land within and adjacent to the Punt Road Car Park, in Cobram, that has been presented by the owner of the adjacent land, as shown on the diagram numbered 048/07 as described within this report;
- 2. Council authorise the CEO to complete negotiations of the exchange of land adjacent to the Punt Road car park with the adjoining land owner, based on the arrangements specified within this report;
- 3. Council authorise the CEO to conclude the exchange, including arranging a title survey and subdivision as necessary; and
- 4. The CEO write to the adjacent owner of land advising of Council's decision.

A formal process for the sale of land has been carried out in accordance with the Local Government Act, Section 189 and the Subdivision Act 1988.

The formal process is now complete and the Council seal is required to be fixed to the transfer of land documentation required by the Land Titles Office.

It is recommended that the common seal be affixed to the formal land transfer documents as required by the Titles Office.
