MOIRA SHIRE COUNCIL DRAFT COUNCILLOR CODE OF CONDUCT

Executive Summary

Following Councillor briefing and feedback, Moira Shire Council's draft Councillor Code of Conduct is now provided for consideration and adoption by Council at a Special Meeting convened solely for the purpose of reviewing the Councillor Code of Conduct.

All Victorian Councils are required to review and update their Councillor Code of Conduct to comply with the Local Government reforms introduced as part of the Local Government (Improved Governance) Act 1989 that came into effect in March this year.

The draft Councillor Code of Conduct has been prepared by Council officers with reference to:

- Council's existing Councillor Code of Conduct
- the MAV model Code of Conduct
- updated Codes recently adopted by other Victorian Councils
- the changes required to comply with the Local Government (Improved Governance) Act 1989
- and incorporates Best Practice guidance and proposals to improve understanding and use of the Code.

All Councils must adopt the Code at a Special Meeting of Council by 4 July 2016. Following adoption, and in accordance with S76 (6) of the Act, Council will

- Provide a copy of the Code to each Councillor
- Make the Code available for inspection at Council's Service Centres and on Council's website

Within one month of adopting the Code, Councillors are required to individually declare they have read and will abide by the <u>Councillor Code of Conduct</u>. The process for making the declaration is defined in the Act.
