Terms and Conditions

1. Promoter

The promoter is Moira Shire Council ("the Promoter").

2. Competition Name

Sign up to Payble – win 1 of 5 Ritchies IGA Vouchers

3. Promotion Period

Register with Payble by 30/10/2026 ("Promotion Period") to be included in the draw for a chance to win 1 of 5 \$100 Ritchies IGA Vouchers. Entries received after this time will not be accepted.

4. Eligibility

Entry is open to all Moira Shire residents/ratepayers who register with Payble for the first time.

Administrators, Employees and immediate family members of Moira Shire Council are not eligible to enter.

The promoter reserves the right to verify the validity of entries and reserves the right to disqualify any entrant for tampering with the entry process. Incomplete entries will be disregarded. The judge's decision in relation to any aspect of the promotion is final and binding.

5. How to Enter

To enter, eligible participants must:

- Scan the QR code on their 2026/2027 Annual Valuation Notice

Personal information will be handled in accordance with the Collection Notice on these Terms and Conditions and consistent with Moira Shire Council's privacy obligations under applicable legislation.
